Representative Cases

- He was part of the team that filed a lawsuit in a highly complex civil dispute arising from the collapse of a conveyor belt in a mining expansion project, involving an international design, manufacturing, and construction contract. The case addresses the determination of civil liability between contractors and manufacturers under the regime of liability for construction defects, construction contracts, and the relativity of agreements. The dispute involves claims for damages in the approximate amount of US\$70,000,000.00. (This is an ongoing process that will begin soon.)
- Commercial litigation for the termination of an operation and maintenance contract for a cogeneration plant for self-consumption in a tourist complex, arising from the unilateral, abrupt, and unjustified termination of the contract without prior notice or operational transition. The total amount claimed is approximately US\$2,000,000.00, in a context of technical and financial complexity of the energy project. (This is an ongoing process that will

begin soon.)

- Obtaining an order for the lifting of a restraining order before the Referral Judge of the Labor Court, demonstrating the urgency of the case, for an approximate amount of US\$240,000.00, within a period of 48 hours, derived from a labor ruling, in order to allow approximately 450 employees to receive their royalties in a timely manner.
- Development of a compliance matrix for a company in the construction sector, to ensure compliance with the parameters that must be respected in the regulation of low-cost housing projects and real estate development in the tourism sector.
